It invites original research in Medicine and Dentistry, as well as contributions in the areas of medical education and public health, all adhering to international standards. JUCMD provides a platform for researchers to publish their work free of charge. The journal comprises sections for editorials, original articles, reviews, case reports/series, and short communications. It aims to foster scientific exchange, prompt new research inquiries, and disseminate research findings across medical and dental health fields. Targeting undergraduates, graduates, post-graduates, post-doctoral researchers, and healthcare professionals, it facilitates the translation of research into practice.

JUCMD employs **double blind reviewing**, in which the reviewer remains anonymous to the author(s) throughout and following the review process, whilst the identity of the author(s) is likewise unknown to the reviewers. Reviewers are requested to evaluate whether the manuscript:

- Is original as to thought and method (including data)
- Is methodologically sound
- Has results which are clearly presented and support the conclusions
- Correctly and exhaustively references previous relevant work
- Follows appropriate ethical guidelines, especially as concerns plagiarism
- Clearly adds to the knowledge and development of the field.

Manuscripts submitted to JUCMD are reviewed for originality. All manuscripts are subject to a similarity check using the Turnitin service, and articles exceeding the limit of more than 19% similarity are returned for clarification and/or correction. The whole process from submission to acceptance of the manuscript takes around 12-14 weeks or less.

Publication Charges: All articles submitted to JUCMD are free of charge. There is no processing, peer review or publication charges.

Privacy Policy: The names and email addresses entered in this journal site will be used exclusively for the stated purposes of this journal and will not be made available for any other purpose or to any other party.

Ethical Approval: Every original article submitted to JUCMD must have an ethical approval by the ethical review board of the institution, written on an official letterhead, duly signed and stamped.

Repository Policy: The Journal of University College of Medicine and Dentistry is an Open Access journal where authors are entitled to make their article publicly available according to the terms of the CC BY license. Authors who have published under a CC BY-4.0 license may share and distribute their articles on non-commercial websites and repositories. There is no embargo period during the whole process from submission to publication, or after publication.

Re-use guidelines for open access content

When uploading, disseminating or repurposing Open Access publications, the journal should be clearly identified as the original source and proper citation information provided. In addition to the Version of Record (final published version), authors should deposit the URL/DOI of their published article in any repository.

Repository Policy for submitted, accepted and online version of manuscript

The original submitted version of an article is the author's version that has not been peer reviewed and at this stage it can be shared online as a preprint without mentioning JUCMD as the source of submission. When an article is peer reviewed and accepted for publication in the print format, the author will be required to clearly identify the journal as the original source and proper citation information provided.

Licensing policy: Publication will allow the author to retain the copyright and share the article under the agreement described in the licensing rights with creative commons, with appropriate attribution to JUCMD.

Creative Commons attribution license CC BY 4.0 is applied to articles published in JUCMD: <https://creativecommons.org/licenses/by/4.0/>, or in certain cases it can be stated that all articles and content there in are published under creative commons license unless stated otherwise. On publication, the author may link to the Version of Record using the DOI or can post the article PDF on website and repositories according to CC- BY license guidelines.

Copyright Policy: Authors retain copyright and grant the journal right of first publication with the work simultaneously licensed under a Creative Commons Attribution 4.0 International License that allows others to share the work with an acknowledgment of the work's authorship and initial publication in this journal.

Authors are able to enter into separate, additional contractual arrangements for the non-exclusive distribution of the journal's published version of the work (e.g., post it to an

institutional repository, in a journal or publish it in a book), with an acknowledgment of its initial publication in this journal.

Withdrawal Policy: If the authors want to withdraw the manuscript during its processing, an email has to be sent notifying as to their intention, to the effect that the manuscript withdrawal form will be emailed for the signatures of all the authors. This needs to be completed, scanned and sent back. A final letter from the editorial office for withdrawal of the manuscript will then be dispatched. Electronic signatures will not be accepted.

Please note that without a formal letter of withdrawal, a manuscript is not considered withdrawn and use of such a manuscript elsewhere will be construed as an ethical misconduct.

Appeal Policy:

Appealing the Editorial Decision

If the author believes the decision to reject the submission by the editor or the reviewer was not in accordance with journal policy and procedures, the author may appeal the decision by providing the editor with a detailed point-by-point response to reviewer and editor comments.

The editor will revisit the peer review process undertaken for the submission. If the decision was made in line with editorial criteria, the decision to reject is final. If the author is dissatisfied with the way the editor has handled their appeal, they may contact at editor.jucmd@journals.uol.edu.pk

Appealing Corrective Action taken Post Publication

If concerns are raised on a published article, the Editor, in line with guidance published by the Committee on Publication Ethics (COPE), including “retraction guidelines” will determine whether a published article needs to be retracted or not. As referenced in the authorship agreement, the journal reserve the right to take corrective action as they deem necessary in the interest of their responsibility for maintaining a transparent and accurate academic record.

General Concerns or Complaints

Any author wishing to raise a concern or make a complaint about any aspect of being published in a journal, should email at editor.jucmd@journals.uol.edu.pk. Our managing editor will then lead the investigation following COPE guidelines. The investigation will establish whether the correct procedures have been followed and assess whether the author’s concerns have been addressed fairly and without prejudice. JUCMD will review the paper’s peer review history and any correspondence between the author, editor, and reviewers. The author will be informed of the outcome in writing.

Retraction Policy:

Retraction of an Unpublished Article

If the authors want to withdraw the manuscript during its processing, an email has to be sent notifying as to their intention, to the effect that the manuscript withdrawal form will be emailed for the signatures of all the authors. This needs to be completed, scanned and sent back. A final letter from the editorial office for withdrawal of the manuscript will then be dispatched. Electronic signatures will not be accepted.

Retraction of a Published Article

Retraction of a published article is considered on the following grounds:

1. If an article has gross errors in the results or the experimental miscalculations are detected after publication.
2. Plagiarism detected after publication
3. Redundant or Duplicate publication
4. Unethical Research results
5. Major Conflict of Interest detected after publication

There is no time bar for retraction.

Guidelines on Ethical Conduct and Publication of Health Research

JUCMD endeavors to maintain the highest ethical standards for the articles it publishes. To do so, the journal follows established international standards and guidelines on the conduct and publication of health research, including the World Medical Association's Declaration of Helsinki, the Council for International Organizations of Medical Sciences (CIOMS), the Committee on Publication Ethics (COPE), the International Committee of Medical Journal Editors (ICMJE), and the World Association of Medical Editors (WAME). JUCMD considers these guidelines as necessary to make its position known and to provide authors with clear and easily accessible information on the important ethical issues to ensure that their papers are ethically compliant.

Ahead of Print Policy: The editorial team of JUCMD recognize the importance of timely dissemination of valuable research findings. In line with our commitment to excellence and innovation in scholarly publishing, we are introducing an "Ahead of Print" publication policy. This policy aims to expedite the availability of accepted articles online before their formal inclusion in a specific journal issue. Accepted articles will be published online as soon as they undergo final editing and formatting processes. These articles will be accessible on the JUCMD website under a designated "Ahead of Print" section.

The "Ahead of Print" publication allows authors to share their research findings with the

academic community promptly. It ensures that groundbreaking research is accessible to readers without delay, facilitating early dissemination of knowledge and fostering academic discourse.

Each article published ahead of print will be assigned a Digital Object Identifier (DOI) for citation and indexing purposes. This ensures that the article is identifiable and citable, providing authors with recognition and facilitating accurate referencing by readers. Ahead of Print articles will be formally included in the upcoming journal issue according to the scheduled publication timeline. Despite their early online availability, Ahead of Print articles undergo rigorous peer review, editorial scrutiny, and quality assurance processes.

Ethical approval: JUCMD expects authors to adhere to the Ethical Principles for Medical Research Involving Human Subjects outlined in the World Medical Association's Declaration of Helsinki and CIOMS. For research involving humans, every research article submitted must include a declaration that before carrying out its field work, the study had obtained ethical clearance from a recognized body in the country, for example, the institutional review boards or research ethics committees. Research involving animals are expected to follow the relevant standards of ethical research. If ethical clearance was not considered to be required, a statement indicating the reasons it was not required must be provided. In any case, authors are expected to follow all requirements of ethical conduct of research, reporting of the findings, and preparation of manuscripts.

Participant confidentiality and respect: Manuscripts should be prepared in such a way that they preserve participants' confidentiality. Authors are expected to obtain an individual's explicit consent for the use of any personal or medical information that may make the participant identifiable and must ensure the dignity and respect of the participants and their communities in their manuscript.

Competing interests: JUCMD requires authors to provide details of any competing interests. A competing interest may occur when an author's personal, family, or institutional interests (e.g. sources of funds, earnings, relationships, etc.) may affect the research, its findings, or publication of the manuscript. JUCMD will not reject a paper solely on the basis of a declared competing interest but will take this into consideration, when assessing a paper and, if considered relevant, including such information in the published paper.

Funding: JUCMD requires authors to state all sources of funding for their study.

Clinical trials registration: JUCMD requires registration of clinical trials in national trials registry before undertaking the trial, as a condition of consideration for publication.
